## **Waterproofing of Basement**

**Whereas**: water leaks in the the basement foundation of the municipal hall are an ongoing issue and are becoming a safety issue;

**And Whereas**: repairing and maintaining the foundation represents a long-term investment for the upkeep of the municipal hall;

**Therefore, Be it Resolved**: that the Rural Municipality of Warren Grove move forward with identifying and applying for funding for the repair and waterproofing of the municipal hall foundation up to a maximum cost of \$20,000.

#### **Letter to Province - Official Plan**

Whereas: Derek A. French Professional Services, who provides planning and permit services for the Rural Municipality of Warren Grove, has informed the Municipality that the 2003 Zoning and Subdivision Control (Development) Bylaw and 2003 Municipal Official Plan are still being used given that the Provincial Government still has not approved the 2016 Zoning and Subdivision Control (Development) Bylaw and 2016 Municipal Official Plan;

**Therefore, Be it Resolved**: that the Rural Municipality of Warren Grove inform the Provincial Government, through a letter, of its disappointment and concern that the 2016 Municipal Official Plan has still not been approved.

#### 9. NEW BUSINESS

# 9.1. Maintenance of building/property

Going forward Dana Harvey has agreed to perform maintenance and small tasks around the Municipal Hall, including any outstanding items and going forward. Additional items around the Hall identified by Council include: purchase of new first-aid kit, hanging smoke detectors on ceiling, winterizing outdoor water faucet and disconnecting forced air vent located inside cabinet under the chalkboard.

### 9.2. Internet for the Municipal Hall

As TAJ is no longer able to share their internet connection with others who use the Hall, a discussion was held on the benefits and disadvantages of Council getting internet hooked up at the Hall. A single quote was obtained from Eastlink. The topic will be brought forward to the January 2023 meeting.

#### 9.3. Roadwork Crew - use of building and cleanliness of site

Brought to attention of Council that the crew working on the bridge has been using the bathroom in the hall and tracking in dirt and water. There are also cigarette butts accumulating around the hall and along the chain fence line. Several residents and Councillors expressed concern coming into the winter and cold weather around the slope and approach of the temporary bridge. CAO will contact the Department. of Transportation and Infrastructure on these items.

# 9.4. Hampshire

With the proposal to dissolve Hampshire moving forward, Council inquired on the dissolution process and, if hypothetically there was a desire from Warren Grove to take on the responsibility for the residents of Hampshire, what that would look like, timelines, requirements, etc. CAO to inquire and report back to Council.

# 9.5. Council Meetings

With the transition to the new term of Council, meetings will be held the second Monday of the month. The next meeting will be Monday January 9, 2023 at 7pm
