4. **BUSINESS**:

4.1 EMO

a. M. Arsenault and D. Arsenault attended the Webinar put on by the Federation of PEI Municipalities (FPEIM) in December. M. Arsenault will be meeting with FPEIM who will provide a list of resources and templates to move forward with the EMO Plan. Potentially still looking at collaborating the EMO Plan with neighboring communities. Given that the deadline for the EMO Plan, including the bylaw, has been extended to December 2021, agreement that the EMO Plan and bylaw will be carried forward until after the meeting with FPEIM and confirmation of collaborating with other communities.
