1. CALL TO ORDER:

5. PUBLIC PRESENTATIONS

5.1. Scott Beamish - Deep Roots Distillery

Deep Roots Distillery would like to be more present and involved in the community. Offered to host a fundraising event at the Hall, where they would take on food and beverages - serve cocktails and drinks - and Council would take on the entertainment/games. A few options were discussed - outdoor yard games, board games, "speed dating" style socializing. Council agreed that fundraising would be a good idea along with increased awareness and a way to bring the community

together. Council would need to acquire a liquor license for the Hall. There have been a few inquiries recently around Hall rentals and consumption of alcohol on site. S. Beamish also invited Council to take a tour of their facilities and suggested that a future Council Meeting could be held in their events tent.

Deep Roots Fundraising Event at the Hall

Deep Roots - Harvest Time Market

That Council collaborated with Deep Roots Distillery to put on a Harvest Time Market, in late September, with the event being advertised in the Municipal Newsletter and Municipal social media channels.

5.2. Joanna Goodman - Tiny Pastures Free Range Child Care

J. Goodman currently runs Tiny Pastures, a small licensed in-home daycare that provides services to preschool children (2-6 years of age). Looking to expand to a before and after school program for school aged children (5-12 years of age). J. Goodman would continue to run the in-home daycare and hire staff to run the program. There is a high demand for before and after school programs. The program would run school days September to June, potentially also have a summer program and be open school holidays. Requirements for this type of program (fenced area, insurance, etc.), and target rental cost were discussed with Council. J. Goodman agreed to send some basic financial information to Council around the anticipated revenue and staff salary fees.

Following the presentation and discussion, Council further discussed rental of the Hall for a before and after school program. All agreed that the aim would be to at least break even, which would include the wear and tear to the building in addition to the costs associated with keeping the building open.

Questions for Tiny Pastures

Moved by Councillor J. MacAllar and Seconded by S. Harvey

That the following list of questions be sent to J. Goodman regarding the before and after school program:

- 1 What does she feel is a reasonable monthly rate for rental?
- 2 What are the expectations from Council (ie. would Council need to put up the required fenced in area?)
- 3 Would there always be two staff on site? What happens if there is an emergency and one staff member needs to leave?
- 4 Does she have previous experience supervising/managing staff at a secondary site?

6. BUSINESS ARISING FROM THE MINUTES

6.1. Discussion with Hampshire

CAO was able to discuss with the CAO of Hampshire their position around amalgamation or annexation. She indicated that there is no interest in meeting to discuss. Hampshire has no intention of pursuing amalgamation, and any annexation would be against their will. They are proceeding with dissolution.

6.2. Flea Market at the Hall

Date set for Saturday May 20th, starting at 9am. Setup on Friday evening, May 19th. Priority for vendors will be given to residents of Warren Grove. Information will be posted on the Facebook Group.

6.3. Spring Newsletter

Target for the next newsletter will be June 2023, and will include: Canada Day Celebration, Community Yard Sale, Public Presentation on the Hall Grounds Improvement, and the Deep Roots Distillery fundraising activity.

Other ideas for engaging with the community were discussed including: highlighting residents, or special events in residents lives, local businesses, etc. Short blurbs monthly on the website and social media as well as in the newsletter.

Distribution of the newsletter was again discussed. Although members of Council distributing the newsletter to residents' doors has created opportunities for discussion and awareness, it is not ideal.
