4 WALKING PATH

- Councillor D. Arsenault is in process of filling out grant proposal for the walking path

- Town of Cornwall suggested an additional grant for the walking path construction, Councillor D. Arsenault will look further into it as deadlines are approaching

5 CEMETARY

- Councillor Keizer spoke with Derek French and has established cemetery falls on Andy Aitken's land
- He thinks responsibility is up to the church that was originally on that location
- cemetery issue now considered not municipality's responsibility.

6 NEW COUNCIL MEETING DAY/TIME

- Council has agreed to host monthly meetings the first Tuesday of each month

## 7 VIRTUAL MEETING

- Councillor J. Noble suggested the Council be open to using virtual platforms for future meetings
- Councillor M. Arsenault will look into any bylaw that prohibits us from having virtual meetings where necessary
- If virtual meetings are permitted, council will begin to host virtual meetings via Zoom in special cases when we cannot meet as a group in person
